## JOB DESCRIPTION

We are seeking a remote Outreach Coordinator to expand our Youth Education Program in Texas, California, Colorado, Washington, New York, Boston, DC, Georgia and North & South Carolina.

# JOB DUTIES

The Outreach Coordinator is responsible for the management and coordination of Nest curriculum sites including outreach to potential school/district partners, implementation logistics, trainings, and material updates and community events. This position is a part-time contracting position, with job duties adjusted accordingly (to be discussed during the interview process).

# **ESSENTIAL DUTIES**

#### Program Development:

- Develop relationships with new schools, districts and stakeholders.
- Develop and maintain communication and logistics among interested and existing schools, facilitators and other collaborating partners and organizations.
- Own all administrative tasks related to school partnerships including: interest calls, SOWs, contracts, invoices, and virtual/in person meetings.
- Work with the Nest team to develop local outreach strategies, as well as policies, procedures and required program documentation.
- Assist in curriculum development and edits as needed.
- Align to national and state educational standards.

### Program Coordination:

- Coordinate (and potentially) deliver trainings for educators, counselors, and facilitators.
- Support the planning of and, if possible, attend community events and conferences, including Nest Student Forums and various school district presentations.
- Contribute local information to curriculum rewrites and coordinate school access of updated materials.

- Ensure successful implementation of Nest curricula.
- Manage surveys and curriculum feedback.

### **QUALIFICATIONS:**

- Bachelor's Degree required; Master's Degree in Education, Social Work or related field helpful but not required.
- Teaching experience is strongly preferred.
- Minimum 3 years' experience in project management position and in a position with progressive responsibility.
- Experience working with multicultural groups and organizations.
- Experience in negotiating and managing contracts successfully.
- Experience working with students and knowledge of school systems welcome.
- Superior and demonstrated organizational skills and ability to work independently.
- Must be organized and self-motivated.
- Excellent communication/writing skills.
- Ability to communicate effectively over email and experience with cloud-based collaboration: Google Suite, Slack, Monday.com, CRMs, with demonstrated success in working remotely
